The Morrisons Foundation prioritises applications from small charities, those with an income of less than $\pm 1m$, but applications from larger charities are welcome.

Before submitting an application, please read our <u>Grant Funding Policy</u> in full. Please note that once an online application has started, it must be completed, there is no method to save your request part-way through.

To help you plan your application, please refer to the questions below that you will need to answer to submit your request:
